GOVERNING LAW; VENUE. These Terms will be governed by and construed in accordance with the laws of the State of New York, without giving effect to any principles of conflict of laws. You hereby irrevocably consent to the exclusive personal jurisdiction of, and venue in, the state and federal courts located in New York, New York, with respect to any disputes arising out of or relating to your use of the VE HUB AND WEBSITE and the VE programming, services, VE Materials and IP, and you hereby irrevocably waive all defense of lack of personal jurisdiction and forum non-conveniens. Any cause of action or claim you may have arising out of or relating to the VE HUB AND WEBSITE and the VE programming, services, VE Materials and IP must be commenced within one (1) year after the cause of action accrues. Otherwise, such cause of action or claim is permanently barred.
